# Victorian Super Sprint Championship Cup day Sandown 1st November 2016

1. The meeting shall be held under the International Sporting Code of the F.I.A., the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Limited (CAMS), the Speed Event Standing Regulations, the Victorian Super Sprint Regulations, these Supplementary Regulations and any Further Regulations if issued. This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at [www.cams.com.au](http://www.cams.com.au).

2. The CAMS Permit Number is 316/0111/02

3. This will be a State Championship Supersprint, promoted by the Ford Four Car Club Inc. To be held at Sandown Raceway on Tuesday 1st November 2016, open to members of clubs affiliated with CAMS in Victoria.

5. Entries open on the publication of these Regulations and close on 03/11/2016 at 9.30am. The field will be limited to 120 entries. Entries will be accepted in order of receipt. The entry fee will be \$240.00 for paid entries received before 30/10/2016 and \$280.00 for entries received thereafter. The promoters reserve the right to refuse any entry, in accordance with NCR 83 and to cancel the event if insufficient entries are received.

6. Scrutineering will commence at 8.00 am and finish at 9.30am. A compulsory driver's briefing that must be attended by all drivers will then take place after which competition will commence. Competition shall consist of a number of multi start sprints, each of one warm up and three individually timed laps.

7. Drivers must present their current Club Membership and CAMS level 2S Licence or Superior to the Event Secretary before their cars will be scrutineered. If issued, CAMS Vehicle Logbook must also be presented.

8. Competition laps will be timed to 1/100th second using the Doriansystem. Prizes will be in the form of trophies awarded as per the Victorian Supersprint Championship Sporting Regulations.

9. There will be a maximum of 20 competing cars on the track at any one time. The circuit is 3.1 km in length and is driven in an anti-clockwise direction

## **10. Classes will be as follows: as per Victorian Super Sprint Championship Technical Regulations**

The Chief Scrutineer will be the Judge of Fact (in accordance with NCR 177) with regard to vehicle safety.

The Championship Eligibility Officer (or their nominee) will be Judge of Fact with regard to Classes. Classes may be combined if there are insufficient competitors in any class. It is the competitor's responsibility to ensure that the competing vehicle complies with the nominated class regulations. Failure to do so may result in the vehicle being re-classified to Category J of the Championship.

11. This event shall be open to all vehicles conforming to Schedule A and Schedule B of the current CAMS Manual of Motor Sport.

12. For All Vehicles, the minimum requirements include:

- Supplementary Bonnet restraints for all vehicles except those with forward hinged bonnets, or two stage restraints
- A safety belt or harness as prescribed in Schedule I of the current CAMS Manual of Motor Sport.
- A fire extinguisher conforming to Schedule H of the current CAMS Manual of Motor Sport. (AS 1841 [except 1841.2]) firmly fitted and readily accessible (BCF/Halon Type extinguishers will not be accepted).
- All open vehicles must have an approved roll bar and the driver must wear approved goggles, or full face helmet..
- Numbers are to be displayed during the course of the competition
- All removable objects (including tools, jacks, spare wheels and wheel trims) must be removed from the vehicle.
- All competing vehicles are required to have an effective muffler in the exhaust system.
- Fuel shall comply with Schedule G of the current CAMS Manual of Motor Sport.

13. Conduct

- Any competitor who after leaving the track re-joins at a dangerous speed or with the wheels spinning will be excluded.
- No passengers are allowed in competing vehicles.
- Any competitor exceeding 10kph in the pits/paddock will be excluded.
- No re-runs will be permitted for driver error or mechanical failure.

14. Whilst competing, all competitors must wear:

- Non synthetic clothing covering all limbs;
- A Helmet conforming with Schedule D of the current CAMS Manual of Motor Sport;
- A Safety belt or harness as prescribed in Schedule I of the current CAMS Manual of Motor Sport.

15. Flags to be used are: Red; Yellow; Chequered; Lack of Adhesion; Black and Mechanical Fault.

## **16. Noise level is limited to 75 dBA, measured 30 metres from the track**

17. Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty (ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

18. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at [www.cams.com.au](http://www.cams.com.au).

19. Protests must be lodged in accordance with Part XII of the NCR.

20. The organisers reserve the right to postpone, abandon, or cancel the meeting in accordance with NCR 59 of the current CAMS Manual of Motor Sport.
